The following letter is being filed in connection with the proposed business combination of Spirit Airlines, Inc. ("Spirit") and Frontier Group Holdings, Inc. ("Frontier"):

Dear Frontier Flight Attendants,

Following up on Barry's note earlier regarding our announcement to combine with Spirit Airlines, I am reaching out to provide some additional color and context on the transaction and what this means for you.

I want to start by thanking you for your continued commitment to ensuring the safety of our consumers and providing them with Frontier's unique brand of superlative and friendly service. You are critical to Team Frontier, and your dedication to our passengers, their safety and their experience with Frontier is at the very heart of everything we do.

I want to reiterate that this announcement is just the first step toward bringing our companies together. Until the transaction is completed, we will continue to operate as usual. Your pay, benefits and scheduling will remain the same and you will continue to work on Frontier aircraft as usual. The most important thing all of us can do is to focus on continuing to provide our consumers with the safe and friendly service they have grown to expect from Frontier.
